**ORDER**

As per recommendation of the State Level Recruitment Commission for Class IV Posts 2023 and communicated vide Govt. letter No. WR (E) 295191/169 dated 10/05/2023 & WR (E) 300572/358 dated 20/05/2023, the following candidate(s) of Person with Disabilities (PwD) category, is/are hereby appointed to the existing vacant post of **Khalasi (MTS)** under the Office of the **Executive Engineer, Darrang W.R. Division, Mangaldoi**, with effect from the date of joining, in the scale of pay Rs.12000 - 52000, with GP-Rs. 3900, subject to fulfilment of the following terms and conditions and satisfactory Notarized Affidavit submitted by the candidates as per the Personnel (B) Department O.M. No. ABP.78/2021/01, dated 18/11/2021 in the format prescribed therein regarding character and antecedents and subject to satisfactory verification of documents and undertakings submitted by the candidate(s).

The candidates so appointed will not be governed by the existing Assam Services (Pension) Rules, 1969 and orders issued thereunder from time to time. They will be governed by a new set of Pension Rules under the "New Defined Contribution Pension Scheme".

**The following are the Terms and Conditions of service for the appointee:**

1. During his/her service period, he/she may be deputed or his/her services may be placed on attachment or on secondment basis to any other department/ sub-ordinate office/ Public Sector Undertaking / Society/ Mission under the State Govt. within and outside the State having the same pay scale and Grade pay for a period decided and specified by the State Govt. on Attachment, Deputation or Secondment basis, or his/her services may be partially placed at the disposal of any other Department/Sub-ordinate Offices, having the same pay scale and grade pay.
2. While on such Deputation or on attachment or placed on Secondment basis he/she shall continue to be guided by the Assam Civil Services (Conduct) Rules, 1965 and Assam Services (Discipline & Appeal) Rules, 1964. While on Deputation or Attachment on Secondment basis or when his/her services are partially placed at the disposal of other Department, the power for any disciplinary action regarding minor penalties shall vest with the Borrowing Authority. However, in case of major penalties, power for any disciplinary action shall vest with the Lending Authority.
3. The services of any selected candidate found to have furnished false/ falsified information regarding educational qualification/ caste/ gender/ EWS status etc. in his/ her application and detected subsequently, will be terminated and legal action will also be taken as per law.
4. Any selected candidate for these Class IV Posts, if found to be overqualified/or found to have suppressed information about over his/her educational qualifications, in terms of the advertisement, during entry in the service, his/her service will be terminated and also legal action will be taken as per norms.
5. Regarding Persons with benchmark Disabilities, they will appear before a Medical Board at Guwahati Medical College and Hospital (**GMCH**) and based on the report received from the Medical Board he/she will be allowed to join by the Appointing Authority.
6. Selected candidates can be posted by the concerned Department at any place within or outside Assam in State Government Department/Agencies.
7. If any Candidate or any of his/her family members is availing benefits under the Orunodoi Scheme at the time of the appointment, he/she or the family members shall voluntarily opt out of the Scheme, as per Orunodoi Guidelines.

I also declare that I do not have more than one wife living (applicable for male candidates) / have married a person who has wife living (applicable for female candidates). I also further declare that I do not have more than two living children on or after 01-01-2021 from a single or multiple partners. In case of any detection to the contrary in due course, I shall be summarily discharged from the Service.**

6. Further, the appointee shall also have to submit a Notarized Affidavit as per provisions of the Personnel (B) Department O.M. No. ABP. 78/2021/01, dated 18/11/2021, may be downloaded from the link available in the website.


